

Dear Second Chance Pell Distance Learning students,

Beginning with the Fall 2019 semester all MATC Second Chance Pell distance learning students will begin working towards a laptop rental program! We have undertaken this initiative so that you will have improved access and flexibility with your college courses at MATC. As part of this innovative program, we have changed the course fee structure so that every student will now be charged a “DOC Technology and Support Fee” of \$180 each semester. This charge includes the laptop rental and classroom support** necessary for you to be able to access your course at your institution. In addition, you will be charged \$70 per course each semester for “MATC Instructional Resources.” This fee accounts for items such as textbooks (digital or physical), paper, pencils, a calculator as needed, and other necessary resources. **Below is a chart of what the costs could look like for a student who receives their full Pell allotment; there are exceptions to the example provided.** In the case where a student may not receive enough Pell money individuals will be evaluated to see if they are eligible for additional state or private grants. Per our agreement, no student who is full-Pell eligible will incur debt as a result of their initial enrollment; if you drop or withdrawal from a course after the semester starts you could still incur a financial penalty.

*Keep in mind that the MATC Instructional Resource Fee could be different than what is shown – for example if a student takes three 3-credit classes they would be charged \$210, but if they took a 4 credit and a 5 credit class they would only be charged \$140. In both situations, the student is taking 9 credits, but since one is taking two classes and the other is taking three, they will have different charges.

**While some items purchased using these fees may be considered student property, many are property of DOC and will be retained by DOC at the end of the semester. For the Fall, 2019 semester, this includes Calculators and Flash Drives for students who do not have one to borrow currently.
