The Problem: Why the Journey?

- **Transfer of credit for work completed in detention schools was a major obstacle for student transition back to the community.**
- **NCLB “highly qualified teacher” designation is difficult for many smaller detention schools with multi-age, multilevel, ungraded structure in limited classrooms.**

The Purpose: What's the Goal of the Journey?

- **Single agreement and rate structure ensures participation by all detention schools to qualify for accreditation regardless of size and/or resources.**
- **Accreditation guarantees that all other schools so accredited will accept credit for work completed by students in detention schools.**
- **Systemic approach addresses NCLB highly qualified teacher compliance.**

- **Being part of the AdvancED accreditation process demonstrates a willingness to be held accountable to the school community and to educational professionals.**
- **Once earned, accreditation is an internationally recognized sign of quality.**
- **The school becomes more focused on improving student achievement, and administrators, teachers, and the school community become involved in the improvement process.**

Accreditation Process

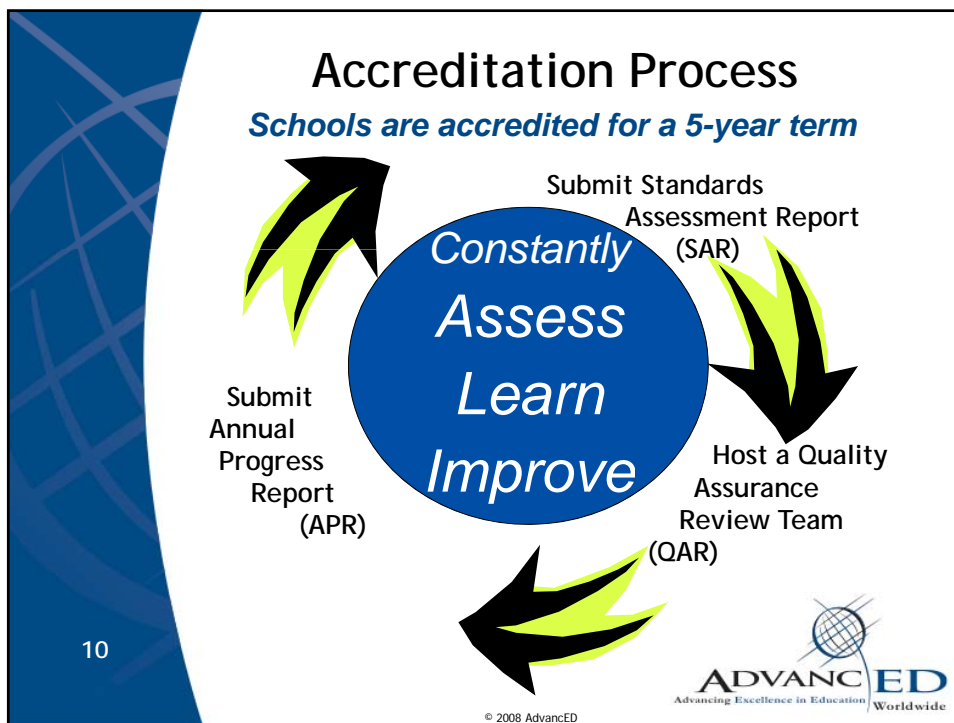
Schools are accredited for a 5-year term

- **Internal Review**
 - The school conducts an internal review of its adherence to the AdvancED accreditation standards.
- **External Review**
 - The school hosts an external review conducted by professional peers.
- **Continuous Improvement**
 - The school continues to monitor, document, and evaluate its improvement efforts.

AdvancED Accreditation Standards

- **Standard**
 - Comprehensive statement of quality practices and conditions
- **Indicators**
 - Operational definitions or descriptions of practices and processes
- **Impact Statement**
 - Characteristics, processes, and actions that would be observable and verifiable in a school that effectively implements the standard

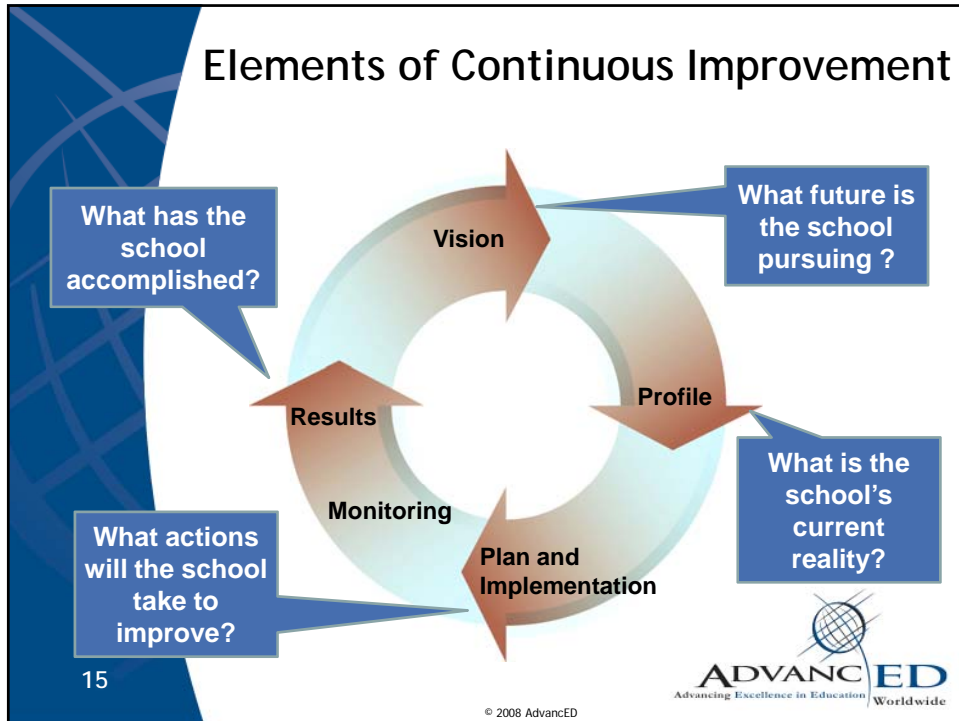
Continuous Improvement Process

- **The school has the *responsibility* and *flexibility* to identify and implement a systemic process of continuous improvement:**
 - One process is used by the school – this promotes continuity, coherence, alignment and collaborative planning.
 - The process contains the four elements of: vision, profile, plan and implementation, and results.
 - Continuous improvement applies at all levels of the school.

- ### *Internal and Ongoing*
- **The school demonstrates organizational integrity.**
 - **The school designs and implements a program of assessment practices and methods to:**
 - Monitor and document improvement
 - Provide meaningful feedback and support
 - Ensure standards are met and strengthened
 - **The school collects, uses, and communicates results.**

Quality Assurance Review Process

External Review Every 5 Years

- **The school hosts an external review conducted by professional peers who**
 - Assess effectiveness of the school in meeting the requirements of school accreditation
 - Meet with school staff and stakeholders
- **The school receives commendations, recommendations, and accreditation recommendation.**
- **Review provides school and community with validation and recognition.**

Essential to Success


Effective Leadership

- Establishes schoolwide direction.
- Develops processes to monitor and maintain efforts.
- Provides support, guidance, assistance, and resources.
- Ensures accountability.

Systems Approach

- Systemic—using and aligning the functions within and across the school to produce improvement
- Systematic —fostering improvement efforts that are regular and predictable
- Sustainable—maintaining and supporting improvements over time
